ADMINISTRATIVE ORDER: 2.075/26-2

IN RE:

APPOINTMENT OF MEMBERS TO
LOCAL PROFESSIONALISM PANEL

WHEREAS, pursuant to Article V, Section 2(d) of the Florida Constitution, section 43.26 Florida Statutes and the Code for Resolving Professionalism Referrals, adopted by the Florida Supreme Court in order SC2023-0884, which directed the Chief Judge of each judicial circuit to create a Local Professionalism Panel to receive, screen and act upon complaints of unprofessional conduct, and to resolve those complaints informally, if possible, or refer them to the Florida Bar, if necessary; and

WHEREAS, pursuant to Florida Supreme Court order SC2023-0844, re: *Code for Resolving Professionalism Referrals*, each member of the Local Professionalism Panel must have practiced law for a minimum of five (5) years. The members shall serve staggered 3-year terms. Terms shall begin July 1st and run through June 30th of the third year; and

WHEREAS, due to the resignation of attorney Sheri Smallwood there is a need to appoint a member to fill the remainder of her term;

WHEREAS, Administrative Order 2.086, *Establishment of Local Professionalism Panel*, set forth the purpose and procedures of the Local Professionalism Panel, including the Chief Judge's authority to appoint the members of the panel;

IT IS THEREFORE ORDERED THAT:


1. Cynthia Hall, Esq. is appointed to fill the remainder of attorney Sheri Smallwood's term.
2. The members of the Local Professionalism Panel and their term expirations are:

 - f. Cynthia Hall, Esq. (Term expires June 30, 2026)

- i. Nick Batty, Esq. (Term expires June 30, 2028)

3. Judge Albert Kelley shall continue as Chairperson.
