ADMINISTRATIVE ORDER 5.032/24-1 AMENDED

PROCEDURES FOR HANDLING VIOLATIONS OF INJUNCTIONS FOR PROTECTION

WHEREAS, Florida Statute Sections 741.2901; 741.2902; 741.30, 741.31, 784.046, 784.0485 and 784.0487 articulate the intent of the legislature regarding acts of domestic, repeat, dating, sexual violence and stalking and require the Office of the State Attorney, the Clerk of Court, and the judiciary to implement procedures for handling allegations of violation of injunctions for protection; and

WHEREAS, the Office of the State Attorney has adopted a pro-prosecution policy for acts of domestic violence and intends that the terms of this Administrative Order set forth its policy regarding the intake of alleged violations of injunctions for protection; and

WHEREAS, it is the intention of the judiciary of the 16th Circuit to provide a consistent and accessible means for the reporting of violations of injunctions for protection throughout the Circuit;

NOW, THEREFORE, IT IS ORDERED AS FOLLOWS:

- (1) In the event of a violation of an injunction for protection when there has not been an arrest, the Petitioner may contact the Clerk of the Court to report the violation. The Clerk of Court is hereby designated as the central intake point for injunction violations. The Clerk shall provide Florida Supreme Court Approved Family Law Form 12.980(w), Petition by Affidavit for Order to Show Cause for A Violation of Final Judgment of Injunction for Protection Against Domestic, Repeat, Dating, Sexual Violence or Stalking, attached hereto, designated as Exhibit "A", to the Petitioner, and the Clerk shall assist the Petitioner in preparing said Affidavit. The Clerk shall also provide the form "Information Sheet for Affidavit Alleging Violation" attached hereto, designated as Exhibit "B", to the Petitioner.
- The Clerk shall forward the completed Affidavit and Information Sheet to the Intake Unit at the Office of the State Attorney, and to the Family Division Judge assigned to the original Injunction case. Should the Affidavit be filed after hours, the Clerk shall also forward a copy of the Affidavit to the duty judge.
- (3) The State Attorney shall determine within five (5) working days from the time the Affidavit is filed whether its office will proceed to file criminal charges and

- will notify the Family Division Judge of its decision by providing a copy of the Information, written statement of its intent to take no action on the allegations, or statement that the case remains under investigation.
- (4) Should the Court have knowledge that the Petitioner, the Petitioner's children, or another person is in immediate danger if the Court fails to act before the State Attorney's charging decision is made, the Court shall initiate contempt proceedings and so notify the State Attorney.

Administrative Order 5.032/03-1 entered into on July 23, 2003 and Administrative Order 5.032/03-2 entered into on October 14, 2003, are rescinded upon date of execution below.
